## Winter Blast - Vendor Terms & Conditions

Dear Vendor:

The West Chester East High School (hereafter referred to collectively as WCEHS) will offer space rental at our Cheer Competition event, known as the “Winter Blast Cheer Invitational” (hereafter referred to simply as The Comp) at WC East High School (hereafter referred to as WCEHS).

Please CAREFULLY read the following terms and conditions below as your signature will constitute a legally binding agreement and also indicate you have fully read, understand and will comply with all the below:

- WCEHS will not be held responsible for accidents, injuries or damages incurred during the event, nor for any loss or theft of merchandise or property
- WCEHS reserve the right to restrict the sale of any items deemed inappropriate.
- No refunds will be issued for any reason other than the event being canceled by WCEHS
- WCEHS does not guarantee the exclusive right of sales for any product or type of product
- WCEHS will not guarantee exact measurement of spaces
- While electricity should be available, WCEHS cannot guarantee the availability of electricity for every space and will be made available on a first-come, first served basis; if electricity is needed please indicate such on your registration and every attempt will be made to accommodate all requests (an additional \$25 fee will be charged); vendors will provide their own electrical cords and power strips – which must be kept properly and safely taped and secured.
- WCEHS will assign a space to each vendor in the location deemed best by WCEHS for maximum utilization of available space.
- **THERE WILL BE NO REQUESTING SPECIFIC SPACES OR SWITCHING UPON ARRIVAL AT THE VENUE.**
- Vendors set up time will be from 7:00-8:00am on **Saturday, November 11, 2023 (Snow Date Nov. 12)**; all unloading must be completed by 7:45am to avoid impeding the entry of spectators at 8:00am. **Bring a dolly to transport your items.** The walk to your location could be a distance.
- Vendors will not deface or damage WCEHS property in any way with nails, staples or any other means and will be held responsible for any such damages incurred to their space
- Vendors agree that they are solely responsible for ensuring their booth and equipment are in safe, working condition and remain that way throughout the entire day; furthermore vendors also agree they are solely responsible for ensuring any and all necessary taxes due to any government or entity are collected and that they are in compliance with any and all local, state, federal regulations including ensuring they have attained all necessary licenses, fees, and inspections to operate their business and sell their product and/or services safely and legally.
- Vendors will vacate the premises within one (1) hour after The Comp has ended (i.e. – the final awards ceremonies have completed); furthermore they are expected to leave their space clean and free of trash and debris upon leaving \* the ONLY exception where WCEHS will grant exclusivity is "home party" based businesses where a national business has many small, independent consultants. Without listing specific names examples would be "home chef", "pampered kitchen", "purse" lines, etc.).
